

## ONLINE PRIVACY POLICY AGREEMENT

The Professor's Advisor values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. ### **Notice to European Union Users**

The company also uses Secure Socket Layer(SSL) for authentication and private communications to build users' trust and confidence in the internet and website use by providing simple and secure access and communication of credit card and personal information. In addition, The Professor's Advisor is a licensee of TRUSTe. The website is also secured by VeriSign.
